- 1. Meeting began at 11:10 am. Opening prayer by Pete.
- 2. Reaching In Maggie
  - a. No July meeting; next meeting is August 11.
  - b. Juggling of upcoming Sunday coverage. Cindy Goller has agreed to do August 3. Will be her first time leading entire service. Thank you, Cindy!
  - c. August 31st will be next outdoor service AND Church Picnic.
- 3. Reaching Out Margaret
  - a. No July meeting; next meeting is August 18.
  - b. Annual School Supplies drive will take place during August.
  - c. Revisited last month's discussion re: appropriate committee for livestream team to fit into.
